## Purposes of the treatment

We process your personal data for the following purposes: to be able to execute and fulfill a contract for the rental of navigation means and the provision of assistance services on the chosen boat and/or complementary services associated with it; for the purpose of sending you newsletters and promotions; to offer you the information requested through the web form; as well as protect our rights and legitimate interests and those of third parties and comply with applicable law.

#### Data collection

You provide them to us directly when you use our services, our website or our social networks, through cookies and similar technologies. We may also collect personal data from third parties.

# **Data categories**

We collect personal data such as name and surname, national identity document number, tax identification number, passport or NIE, nationality, address, email, telephone, IP address, location, device ID, bank details and financial and payment information., data about their obligations. In certain cases, we may process health data.

## Legitimation

By your consent; on the basis of a contract, when the data is necessary for the performance of the contract; or based on our legitimate interest. In the event that we have to process health data, with your consent, by virtue of a vital urgency or by virtue of our legitimate interest in the event of claims.

## .4. Purpose of data processing

We process your personal data for the following purposes:

- As well as to protect our legitimate rights and interests and those of third parties and comply with applicable law.

In the same way, we treat your personal data when:

They are necessary to comply with our legal obligations (for example, comply with the
duties of information before supervisory authorities or the Spanish Agency for Data
 Protection or before any other competent authority, to identify and prevent fraud and money
laundering of capital, the financing of terrorism and any other criminal or illegal activity).

- The treatment is necessary to safeguard our legitimate interests in the management of our business, including in relation to (i) the management and execution of your contract for the rental of navigation equipment and the provision of assistance services, including, in your case, recover debts; contact you, including to inform you about any changes related to our services or our contractual relationship; (ii) improve our products and services; (iii) prevention of criminal activities; (iv) for statistical and market research purposes, and to measure and understand the effectiveness of the advertising we serve to users; (v) administer and improve our web pages, ensure security and guarantee that the contents are presented in the most efficient way on your device, provided that these interests are not contrary to your interests and rights; and
- For marketing purposes, with your consent, which you can revoke at any time.

Information you provide to us:

We collect the information you provide us:

Information we collect about you automatically:

Each time you visit our website, we may automatically collect the following information:

- Technical data, such as the type of device, IP address and Internet provider used to connect the device to the network, access data, browser type and version, time zone, plug-in types and versions, platform and operating system, screen resolution, location, character encoding.

Information we receive from third parties:

We may request information about you from third parties, such as other group companies, at all times respecting data protection regulations and, if necessary, requesting your prior consent. We may receive information about you:

- Of those commercial partners with whom we collaborate in the contests, promotions or surveys in which you participate;
- From business partners in charge of providing technical, payment and delivery services, ad networks, analytics providers, and search providers when they offer services to us;
- From third parties that market our services (travel agencies, resellers, etc.)

## 8. Interested parties' rights

Likewise, you have the right to file a claim regarding the processing of your personal data before the Spanish Agency for Data Protection (<a href="www.aepd.es">www.aepd.es</a>).

# Access right:

You have the right to ask us about the personal data we process about you and the purpose and nature of its processing, as well as to provide you with information about who we plan to share it with (unless the provision of such information is prohibited by law). You may ask us for a copy of the information we process about you in order to check what information we have. Said copy will be free, provided that it is not manifestly unfounded or excessive requests, especially due to their repetitive nature.

## Right of rectification and deletion:

You have the right to ask us to update, correct or delete (as long as this does not affect the services we provide to you) your personal data at any time. Please note that we may deny requests that put third parties' privacy at risk, are repetitive or unreasonable, or require disproportionate effort. However, please know that we are subject to a series of legal obligations that prevent us from immediately deleting your personal data. These obligations emanate from the legislation against money laundering, tax regulations and laws on consumer rights, among others.

## Right of revocation:

## Right to limitation of processing:

You have the right to request the limitation of the treatment of your personal data in the cases established by law, for example, in case you consider that the treatment that is being carried out is illegal (but you do not want to request the deletion of said data), or if you understand that the person in charge no longer needs your personal data for the purposes for which they were collected, but you need them for the formulation, exercise or defense of your claims.

## Portability right:
